Cancellation charges: PGL have COVID cancellation protection which means that if your child cannot attend due to a government imposed lockdown, DfE advice against school travel or a NHS acknowledged requirement for your child to isolate, you will receive a full refund including the deposit.

Please note the terms and conditions for non-COVID related cancellation charges:

- Cancelling more than 56 days before departure = Loss of deposit and first payment.
- Cancelling 56-29 days before departure = Loss of 60% of the total trip cost.
- Cancelling 28-15 days before departure = Loss of 80% of the total trip cost.
- Cancelling 14 days or fewer before departure date or afterwards = Loss of 100% of the total trip cost.
